CONDITIONS OF PARTICIPATION

GRINDINGHUB DIGITAL 2024

1. SCOPE

1.1 The following Conditions of Participation apply to participating in the digital offers relating to GrindingHub 2024, which will be hosted from 14 to 17 May 2024 (exhibition period) by VDW – Verein Deutscher Werkzeugmaschinenfabriken e.V. [German Machine Tool Builders' Association] (referred to hereinafter as the "Organiser"), Lyoner Straße 18, 60528 Frankfurt am Main, Germany.

1.2 Any other or supplementary conditions submitted by or pertaining to exhibitors or visitors and/or users (both referred to hereinafter as "Participants") shall not apply.

2. REGISTRATION AND CONCLUSION OF CONTRACT

2.1 Those applying to participate in the digital offers of GrindingHub 2024 agree to the Conditions of Participation on submitting the application/registration form, fully completed in writing, to the Organiser. The Participant's registration is binding. The contract becomes binding when registration is confirmed by the Organiser.

3. PARTICIPANTS

3.1 Participation is exclusively reserved for companies who are registered for GrindingHub 2024 and whose business portfolio comprises the manufacture or sale of the products named in the following or services relating to them:

- Grinding machines
- Tool processing systems
- Machine parts and accessories, clamping technology, controllers
- Grinding tools, abrasives and dressing technology
- Machine periphery and process technology
- Measuring and testing technology
- Process periphery
- Software
- Services
- Education, research, organisations

3.2 The digital offers of GrindingHub 2024 are addressed to trade professionals. In addition to all companies fulfilling the criteria listed in Section 3.1, access is also granted to other commercially active and interested professionals. The offer does not extend to consumers.

4. ELECTRONIC DISPATCH

4.1 Participants shall receive documents addressed to them, e.g. invoices, as non-encrypted e-mails sent to the e-mail address specified by each Participant. These documents are deemed to have been delivered once the e-mail has entered the Participant's domain (the Participant's e-mail account with his/her internet provider) where acknowledgment of receipt may be expected under normal circumstances. Participants are responsible for checking their electronic inboxes regularly and for ensuring that e-mails from the Organiser can be received at all times. Participants must inform the Organiser immediately of any change of e-mail address.

5. ACCESS DATA AND CONDITIONS OF USE

5.1 Each participant must register to use the digital offers, either on www.grindinghub-digital.de or on www.grindinghub.de. Access will then ensue via the login generated there.

5.2 Participants are under obligation to keep their access data in a safe place and to protect them from unauthorised third-party access. Participants must inform the Organiser immediately whenever they have reasonable grounds to suspect that an unauthorised third party has gained cognisance of the access data and/or that unauthorised access has occurred.

5.3 The Participants themselves must fulfil at their own costs the requirements and technical conditions needed to use the services provided – especially with respect to an adequate power supply, a stable internet connection and the availability of an up-to-date browser. The system requirements for use can be viewed at www.grindinghub-digital.de/system-check. For all offers that require in-person attendance, Participants must ensure that the agreed time periods and preparations are properly observed. If and when this should prove impossible, the Organiser must be informed without delay. In the event of non-appearance, there shall be no reimbursement or waiving of the payment to be made.

6. EXCLUSIVE EXHIBITOR VIDEO

- 6.1 The video production offer can be booked as a separately payable service and registration made accordingly. Exhibitors have the option of booking a recording time slot for a film shoot, which will last 30 minutes at the most. The subsequent running time of the video clip will be between three and five minutes. Exhibitors can design the contents of the video as they wish, with the proviso that it may solely serve the purpose of presenting the company, the trade fair stand, the products and services listed in Section 3.1 or topics immediately relating to these. As a further aspect of this service offer, exhibitors also have the option of making their appearance in a production series with other exhibitors on a thematic focal issue. The video production may only and exclusively be used for the aforementioned purposes and is not available for the presentation of extraneous subjects. Section 6.2 sentence 3 shall apply accordingly.
- 6.2 In the interest of more effective advertising and preparation measures, the Organiser must be informed at the latest 14 working days prior to the commencement of the exhibition period of the subject of the video and of those appearing in it on behalf of the exhibitor. The Organiser will forward the contact data of the contact person designated for the production, the service provider the Organiser has engaged for delivering the "exclusive exhibitor video" production service offer, and to the video production company chosen by the Organiser. The requisite contract data processing agreements in terms of data protection law (Art. 28 GDPR) were made both with the aforementioned service provider and with the aforementioned production company.
- 6.3 The recording will be done live at the trade fair stand. The exhibitor is responsible for ensuring that the stand facilities meet the necessary requirements so that the talk and/or the products can be presented within the specified time slot and that those appearing on behalf of the exhibitor arrive punctually and are present at the arranged time at the stand. In the event of the recording proving impossible due to any hindrance of the person or persons foreseen by the exhibitor for taking part in the shoot, or due to circumstances whereby the stand facilities fail to meet the aforementioned requirements, this shall not free the exhibitor from his/her obligation to pay.
- 6.4 Participants can book a moderation, which will be provided by the Organiser. The costs for this are included in the package price, even if no such booking is made. Participants are at liberty to provide their own moderation.

7. FORUM

- 7.1 The forum offer can be booked as a separately payable service and registration made accordingly.
- 7.2 Exhibitors have the option of booking a time slot for a 20-minute spoken contribution to the GrindingHub Forum in Stuttgart. The talks will be recorded and subsequently posted online. In terms of content, they should be oriented towards the items and services enumerated in Section 3.1, and they should be utilised for the purpose of presenting these or lecturing on associated topics (especially application examples and best practice solutions). The talks may be used exclusively for this purpose and are not available for the presentation of extraneous subjects. Section 6.2 sentence 3 shall apply accordingly.
- 7.3 In the interest of more effective advertising and preparation measures, the Organiser must be informed of the subject and the speaker at the latest 14 working days prior to the commencement of the exhibition period. The Organiser will forward the speaker's contact data to the service providers he has engaged for delivering the video production service offer. The requisite contract data processing agreements in terms of data protection law (Art. 28 GDPR) were made with both of the aforementioned service providers.
- 7.4 In addition to the envisaged speaker, the exhibitor must also nominate a suitably qualified person who is in a position to substitute adequately for the speaker in the event of short-term hindrance. Any hindrance to the speaker must be reported immediately to the video production organiser. In this event, the exhibitor is obliged to ensure the qualified realisation of the recording with the person appointed as deputy speaker.
- 7.5 Both parties are under joint obligation to ensure a successful implementation and to employ suitable and appropriate measures in advance to make potentially interested parties aware of the GrindingHub Forum, thereby canvassing for participants in the talk. This does not constitute an obligation on the exhibitor to implement advertising measures at their expense.
- 7.6 The talk will be held in Hall 10 on the forum stage and recorded there. The exhibitor must ensure that he/she meets the requirements for presenting the talk in the designated time slot, and that the speaker arrives punctually and is present at the arranged time at the forum. He must likewise ensure that he allows sufficient time for the subsequent round of questions with the audience.
- 7.7 The forum will be moderated by the Organiser.

8. RECORDING, STORAGE AND PUBLICATION

8.1 The Organiser has the right to record and store the video productions, presentations made in the context of the video production and spoken contributions to the GrindingHub Forum. The exhibitor grants the Organiser the right to publish the recorded material on the Organiser's own web pages and social media channels, such as the video portal www.youtube.com in particular. The exhibitor is obliged to secure the consent of his/her appointed speaker to such publication and exempts the Organiser from any claims the speaker may submit on the grounds of such publication. The exhibitor and/or the speaker have the right to object in text form to the publication no later than five days before the commencement of the exhibition period. Moreover, the exhibitor and/or the speaker have the right to object to continued use, stating their reasons. In this event, the Organiser will request the affected portals to delete the video for future use. The Organiser is not subject to farther-reaching obligations.

9. PRICES AND EXHIBITOR'S OBLIGATION TO PAY

9.1 The following net package prices apply for GrindingHub digital offers:

Offer prices and all other fees are net prices supplementary to which value added tax at the respective specified statutory rate will be shown and is also payable.

9.2 The exhibitor is under obligation to pay the participation fee for the range of services he/she has selected.

9.3 The invoiced sum is due immediately on receipt of the invoice. On defaulting, the Participant is under obligation to pay in addition the statutory default interest of nine percentage points p. a. above the base rate. This does not affect any other claims or rights on the grounds of default.

10. PARTICIPATION AS VISITOR

10.1 Participation is free of charge to Participants who are not exhibitors, but are taking part as visitors in the programmes of GrindingHub 2024. The same applies to users who have registered on www.grindinghub.de or www.grindinghub-digital.de.

11. FURTHER CONTRACTUAL OBLIGATIONS OF THE PARTICIPANT

11.1 The Participant is under obligation to utilise the digital services on offer exclusively for the agreed contractual purpose and not to abuse them for other purposes.

11.2 The Participant is under obligation, when using the chat function, and in video calls and forum contributions, to accord respect and to strictly avoid all and any insulting behaviour and/or personal attacks. The exhibitor is under obligation to ensure that his/her appointed speaker observes these conditions.

11.3 The Participant is also under obligation to refrain from in any way compromising the operability and reliability of the services on offer and from permitting unauthorised access to third parties.

11.4 Each and every Participant is responsible for the content(s) they upload, present or deliver (e.g. product and process descriptions, images, copy, graphics, chat posts, and video production and/or video production talks), including any web pages linked to (referred to collectively hereinafter as "Content"). The Participant pledges that the Content he/she has provided neither violates applicable law nor encroaches on third party rights. The Participant must ensure in particular that the Content he/she has uploaded or presented does not exhibit any culpable, improper or immoral aspects nor can be considered to be objectionable, racist, glorifying violence or otherwise discriminating.

11.5 The Participant exempts the Organiser from third party claims on the grounds of legal violations as set down in Section 12.3 and is obliged to reimburse the Organiser for all and any damages and expenses incurred in this respect unless the Participant can prove that he/she is not responsible for the violation.

12. LEAD GENERATION

12.1 The Organiser will store the contact data provided by participating users when registering in order to forward them to the implementing exhibitor (video production, exhibitor videos and/or forum presentations) after GrindingHub 2024 and/or the GrindingHub video production. Contact data will not be forwarded to all exhibitors. As regards the electronic transmission of contact data, we refer to Section 4 of these Conditions of Participation.

13. DISABLEMENT

- 13.1 The Organiser reserves the right to deactivate the exhibitor's digital presentation and/or to disable a Participant's access to the services on offer if the Participant violates these Conditions of Participation or legal provisions. If an exhibitor defaults on fulfilment of obligations, the Organiser will instigate deactivation or disablement only after a prior request to the exhibitor to resume these obligations, unless consideration of mutual interests justifies immediate deactivation or disablement.

14. INTELLECTUAL PROPERTY

- 14.1 The Participant grants to the Organiser, for the purpose of preparing and implementing the event and the associated advertising measures (especially for use in magazines for designing the lecture programme and for advertising the event on social media platforms and elsewhere), a temporary, non-exclusive right of use, especially for logos, brands, product images, product videos and/or depictions in writing or graphics, without geographical constraints and free of charge.

15. CONTRACTUAL OBLIGATION; FORCE MAJEURE

- 15.1 The contract for the respective digital service offer(s) becomes binding on registration. If, notwithstanding the binding registration, the exhibitor does not avail himself/herself of the digital services he/she has booked, he/she shall remain under obligation to pay the agreed prices (if applicable, taking into account any other possible income the Organiser has received or costs the Organiser has saved because these services were not used). In addition, the Organiser has the right under statutory conditions to file a claim for damages against the exhibitor in the event of his/her non-participation.
- 15.2 If the Organiser is prevented from implementing GrindingHub 2024 in full or in part owing to reasons for which the Organiser is not responsible, he/she is entitled to reschedule, shorten or cancel the trade fair, including the digital service offers. This applies specifically, but not exclusively, when legal regulations, ordinances, decrees or official directives prevent GrindingHub 2024 from taking place, insofar as this was not known and could not have been known by the Organiser at the time the contract was concluded.
- 15.3 In the event of rescheduling to another date, the exhibitor has the right to withdraw from the contract if and when he/she can prove that he/she is unable to participate on the new date, or consideration of all circumstances and of the justified interests of both parties leads to the conclusion that he/she may not be reasonably expected to participate. The withdrawal, together with the reasons for it, must be communicated to the Organiser in text form immediately the new date has been announced.

16. LIABILITY

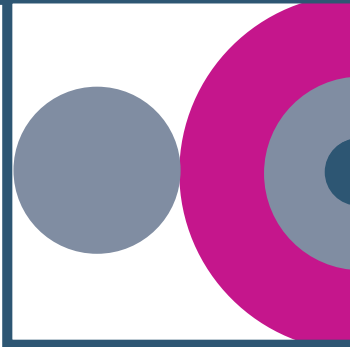
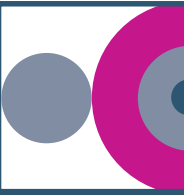
- 16.1 Subject to the following regulations, the Organiser shall be liable only for intent, gross negligence and culpable violations to essential contractual obligations. Essential contractual obligations are those, the fulfilment of which is vital to achieving the contractual purpose, and on adherence to which the Participant routinely relies and may rely. In the event of ordinary negligence posing a violation to essential contractual obligations, liability is limited to contractually typical and foreseeable damages.
- 16.2 This does not affect liability for culpable harm to body, health or life.

17. DATA PROTECTION

- 17.1 The parties are under obligation to comply with applicable data protection regulations, and specifically with GDPR. Otherwise, Participants are referred to the Organiser's privacy policy appended to the application/registration documents and retrievable at www.vdw.de/datenschutzhinweis/.

18. VENUE AND APPLICABLE LAW

- 18.1 The law of the Federal Republic of Germany shall apply.
- 18.2 The venue for all disputes arising from and in connection with the contract is the Organiser's head office. The Participants are subject to this venue only. Alternatively, the Organiser also has the right to sue the Participant at the latter's place of general jurisdiction.
